Happy New Year! I hope everyone is starting 2024 healthy & happy!

A new year means an opportunity to regroup & reorganize. For anyone receiving services from our agency, please remember to save your 2023 income verification, including tax returns, social security and/or pension award letters, etc. Income verification is required for most services annually. If you need assistance in 2024 with tax preparation, The United Way of Lackawanna, Wayne & Pike is once again offering the Volunteer Income Tax Assistance (VITA) Program to prepare local, state and federal income tax returns for FREE! There are NO hidden fees or charges - this is a completely FREE Service designed to help people secure all the refunds and credits for which they are eligible. Starting Tuesday, January 3rd, call 570.602.3133 or 866.662.8887 and speak to an agent that can book your appointment over the phone. Please leave a voicemail when/if prompted.

Every January, I look at my family's spending and investigate ways that can help us save money. If you're a retired senior citizen, there's a good chance you're living on a fixed income. That means you're probably on the hunt for ideas to save money as well.

You're in luck. Some of these money-saving strategies will work for any age, but most are aimed at people in their 60s or older. Hopefully, they'll help or inspire your own money-saving ideas. LIHEAP

Purpose: To assist households with low incomes, particularly those with the lowest incomes that pay a high proportion of household income for home energy, primarily in meeting their immediate home energy needs.

Property Tax/Rent Rebate Program

CHANGES STARTING IN 2024

Starting January 16, 2024, the Department of Revenue will open the filing period for eligible applicants to submit applications for rebates on property taxes and rent paid in 2023. Here are the changes that will take effect at that time:

- The maximum standard rebate is increasing from \$650 to \$1,000
- The income cap for both renters and homeowners will be made equal and increase to \$45,000 a year
- The income cap for homeowners will increase from \$35,000 to \$45,000
- The income cap for renters will increase from \$15,000 to \$45,000
- The income caps will be tied to the cost-of-living moving forward, meaning those who receive a rebate won't lose their eligibility in the future due to no fault of their own

SHARE shared housing and resource exchange

Shared Housing and Resource Exchange (SHARE) is an affordable housing choice that brings together homeowners who want to share their home with home seekers who are looking for housing in exchange for rent, help around the house, or a combination of both. The home seeker receives their own bedroom and agreed upon use of the common areas. One person in the arrangement, home sharer or seeker, must be at least sixty years old. Every arrangement is unique depending on the needs, preferences, and abilities of the participants involved. Lackawanna County AAA Seeks Dom Care Providers

The Domiciliary Care Program, or Dom Care, is a unique program offered through the Lackawanna County Area Agency on Aging (LCAAA). Dom Care is commonly referred to as Foster Care for adults.

LIVING ALTERNATIVE

Dom Care provides a quality alternative for those who are unable to live independently due to physical, mental or age-related impairments. The program offers consumers care and supervision within a family-type environment with a certified Dom Care Provider. Individuals receive room, board, personal care assistance, and emotional support.

Unlike larger personal care homes, Dom Care homes are the individual providers' homes. Providers must be certified by the LCAAA to house one to three consumers at one time.

The 2024 Dom Care rate to be paid to the Dom Care Provider is \$1,294.16 for an individual and \$2,272.20 for a couple. Dom Care consumers will receive a monthly spending stipend of \$283.14 per individual or \$490.20 for a couple in 2024.

CAREGIVING OPPORTUNITY

Dom Care Providers are currently in high demand. The program is seeking people residing in Lackawanna County interested in the opportunity to become a certified Domiciliary Care provider. Providers must be at least 21 years old and demonstrate that they have the experience and ability to care for persons with physical, mental, and age-related disabilities.

Dom Care homes are certified annually to ensure they meet health and safety standards. Once certified, providers will be matched with consumers in need and will receive a monthly stipend for providing the necessary care.

Once the LCAAA matches a certified provider with an eligible individual, the individual will move into the provider's home. Providers are responsible for providing room and board, transportation for medical and other appointments, medication management, and preparation of healthy meals.

Most often, consumers and providers grow to become like family. In the past, some providers have included consumers in family events, and have even taken their consumers on family vacations.


